 - c) Avoid dating the POA139 as it may become stale-dated
 - d) One POA139 per type of security (i.e. BCE Common and BCE Preferred require two POA139)
 - e) POA139 must be original with original signature. Recommend signature in blue ink to ensure that it is clear that it is not a photocopy.
